2021 Single Family Consolidated Request for Proposals Reminder

The [Single Family Consolidated Request for Proposals \(RFP\)](#) was launched on April 14 and provides funding for single family, owner-occupied affordable housing activities throughout the state. The 2021 Single Family RFP application deadline is **Thursday, July 15, 2021 at 12:00 p.m.** Applicants must submit an electronic copy of the completed Single Family RFP application materials, including all required documentation, to Minnesota Housing by the application deadline. Submissions that are late or substantially incomplete will not be accepted.

Vistability and prevailing wage apply only to new construction projects.

NOTE: Vistability and prevailing wage do not apply to affordability gap, owner-occupied rehabilitation, or acquisition, rehabilitation, resale activities. If you are applying only for these activities, it is not necessary for you to view this webinar.
