

**Eligible Participants**

- Hospitalized at Anoka Metro Regional Treatment Center (AMRTC) or Forensic Mental Health Program (FMHP) (fka St. Peter Regional Treatment Center-SPRTC) and does not meet hospital level of care, \* **AND**
- Homeless or at significant risk of homelessness upon AMRTC or FMHP admission or discharge, **AND**
- Eligible for a HUD Section 8 housing choice voucher or will be eligible in the future.

\*People who are at a community hospital as an alternative to hospitalization at AMRTC and are on the waiting list for AMRTC may also be eligible if diversion from AMRTC hospitalization is demonstrated. People may transition from a regional treatment center (RTC) to an intensive residential treatment services (IRTS) facility or other facility or treatment center and remain eligible for a Bridges RTC voucher.

The Transition to Community Initiative (TTCI), pursuant to [Minn. Stat. § 256.478](#), was established in 2013 to reduce the time that individuals remained at the Anoka Metro Regional Treatment Center (AMRTC) or the Forensic Mental Health Program (FMHP) when services were not clinically necessary. To accomplish these goals, TTCI provides a wide array of services to address a person’s unique needs and in 2015 began the “Whatever it Takes (WIT) program to enhance creative solutions that address the needs of their target population. In addition to the WIT services, the TTC program can provide grants to counties when there are no other funding resources to address discharge barriers. By providing additional funding to address the unique discharge barriers faced by some individuals, the initiative promotes recovery as well as opens up beds at AMRTC and FMHP for other individuals who need them.
