Community Need Methodology

Community Need for housing aid is determined by evaluating whether eligible Tier II cities have a large share of cost burdened¹ households and a large share of households with household incomes less than \$75,000. Each measure of Community Need is evaluated and scored separately and worth a maximum of 15 points per measure. Tier II cities are analyzed and scored in comparison to other Tier II cities in their region.

Large Share of Cost Burdened Households (up to 15 Points)

The first category evaluating a Tier II city's need for housing aid is the share of all households in that city that are cost burdened by housing costs (rent/mortgage, taxes, insurance, and utilities). A cost burdened household spends 30% or more of its income on housing.

Tier II cities are evaluated for cost burden in comparison to other Tier II cities in their region. The regional comparison helps to account for differences in cost burden found across the state. All applicants fall into one of four scoring tiers, with the highest tier earning the maximum 15 points.

- **Scoring Tier 1 (15 Points):** The top 25% (highest quartile) of communities in the region those with the highest percentage of cost-burdened households.
- **Scoring Tier 2 (11 Points):** The next 25% (second highest quartile) of communities those with slightly lower but still high percentages of cost-burdened households.
- Scoring Tier 3 (7 Points): The next group of 25% (third highest quartile) communities with a moderate percentage of cost-burdened households.
- Scoring Tier 4 (3 Points): The bottom 25% (lowest quartile) of communities those with the lowest percentage of cost-burdened households.

Large Share of Households with Incomes Less Than \$75,000 (up to 15 Points)

The second category evaluating a Tier II city's need for housing aid is the share of all households in the city that has a household income of less than \$75,000. This criterion identifies cities that may not have a large share of cost burdened households but do have a large share of households that may not have incomes to support an unforeseen expenditure jeopardizing their housing and/or financial stability.

¹ Cost burden is defined as spending 30% or more of household income on housing costs (rent/mortgage, taxes, insurance, and utilities). Data Source: 2023 5-Year American Community Survey (ACS) Estimates.

Tier II cities are evaluated for having a large share of households with incomes less than \$75,000 in comparison to other Tier II cities in their region. The regional comparison helps to account for differences in household income found across the state. All applicants fall into one of four scoring tiers, with the highest tier earning the maximum 15 points.

- **Scoring Tier 1 (15 Points):** The top 25% (highest quartile) of communities in the region that have the largest share of all households with household incomes less than \$75,000.
- **Scoring Tier 2 (11 Points):** The next 25% (second highest quartile) of communities that have the largest share of all households with household incomes less than \$75,000.
- **Scoring Tier 3 (7 Points):** The next group of 25% (third highest quartile) that have the largest share of all households with household incomes less than \$75,000.
- **Scoring Tier 4 (3 Points):** The bottom 25% (lowest quartile) of communities that have the largest share of all households with household incomes less than \$75,000.
